#### Keyboard Not Working

Cordless unit not working, Mouse O.K.

Tried new batteries, two sets.

No Joy

#### New MBB Modem Battery Problem?

The modem uses a cable connection to the Desktop PC, other devices (TV etc.) use the WiFi ports.

Battery runs out of puff when left on all day.

Battery capacity probably inadequate.

Ensure that it is fully charged.

Log service duration.

Check the performance specification.

Try running it with the charger on, ensuring adequate ventilation for cooling.

As it is an MBB device it is possible that continuous use for a full day was not envisioned by the maker.

As it is used as a substitute for an NBN service, a Telstra 5G Home Internet Service may have been a better option.

This uses mains power, no battery required.

Another option is to use a USB modem plugged into the Desktop PC with the WiFi Ports for the other devices, no battery required.

#### Laptop does not start.

When on battery, check that battery is charged.

Battery may have failed/died.

Try using the power pack.

We did not have a Power Pack with which to check.

Bring it all to the next meeting.

#### Unable to Access Camera

Unable to download photos from camera.

Possible causes:-PC Driver or camera makers software.

The camera could be faulty or inadequate battery charge.

Apps You Run on Your Computer Are ".exe" files

Your device (Windows or Apple computer, iPhone, iPad, or whatever) runs "apps," which is a term short for "applications". An app is a program or a set of instructions for the computer to execute or "run." They are why you have your device. Although apps can run on any device, to keep it simple, let's look at how an "app" runs on a Windows computer (almost the same on any device).

When you purchase your device (Windows computer), it comes with many apps that have already been installed and are ready to go. Some very helpful apps with Windows are WordPad, Paint, Calculator, and many others, such as some games, utility apps, and more. You are probably unaware of all the apps that come with Windows that have already been installed. If you want an app you do not have, like a game, Microsoft Word, or Firefox, you must DOWNLOAD and INSTALL it on your device. You are downloading and installing an EXECUTABLE computer file; that is, it can "run" on your device. This file type has a name that ends with ".exe," meaning "executable."

You are probably already aware of a "file" on your Windows computer. A file can be a text document, a photo, or a spreadsheet. If you wanted to create or write a new app from scratch, you would write the app using computer language and write it in a file, too. But what you are doing by writing an app is you are giving commands or instructions for the computer to follow. Suppose you were writing a game app to play tic-tac-toe on your computer; you would have to write instructions for the computer to recognize where each X or O is on the grid and where to place the next move. So this app is written as a file just like any other file except the name of this kind of file ends with ".exe." If you have downloaded (that is, copied a file from somewhere else, like a website, for example), you probably have noticed that the name of the file you downloaded ends with ".exe." In Windows, one

way to run such a file is to click your mouse on the file name – your computer sees it as an executable file and runs it.

It is the same if you double-click an app icon on your desktop; you tell the computer to run that app.

Maybe you get notices that there is an update to an app you already have. If you download the update, it is an executable file (a ".exe" file) that you click on to run the update.

Exe files are not for you to open and look at or change. They are in computer or machine" language that you would not be able to understand. But they ARE just files stored on your computer in a program or apps folder. To remove an app from your device, you must UNINSTALL it using a Windows or other utility app to do that. Please do NOT attempt to find the executable file yourself and delete it.

If you want to learn more about executable files or apps, ask Google and watch a short video or two about it. But most of us want the app to run so we can use our device how we want.

#### **Backup Tools and Procedures**

It's been a few years since I've written about tools and procedures for backing up your computer. With the growing popularity of smartphones and tablets, the need for backup has expanded to include those devices and traditional Windows, Macintosh, and Linux PCs. I can't stress enough how important it is to make regular backup copies of your data files and of your computer's entire hard drive. The backup landscape has changed somewhat, so it seemed a good time for an update.

## What is Backing Up?

Backing up means accurately copying some or all of the data and software stored on your computer's storage drive. The copy is commonly stored on some type of external storage device that is not generally connected to your computer. The external device may be a USB hard drive or flash drive, a removable rack-mount hard drive, a folder or partition on another computer on your in-house network, or a server elsewhere on the Internet such as Dropbox, MS OneDrive, or Google Drive. A personal backup solution may include some or all of the above.

# Why Back Up?

The reason to make backups is that (putting it politely) **BAD STUFF HAPPENS!** Computer equipment is highly reliable and may run for years without failing, but sooner or later, storage devices fail. More commonly, accidents (drops and spills, turning off the PC's power, power failures and power surges, and so forth) happen, causing a storage device or other device component to fail. A vast array of malicious software waits for any opportunity to attack, damage, or lock up saved data. There's also a fundamental human error – accidentally deleting a file or a folder.

Without a safe backup copy, data saved on your computer may be irretrievably lost. For example, consider digital photos, videos, music, and financial / tax records. Also, if you had to start over with a new, blank hard drive, it would be relatively easy to reinstall Windows, Linux, or MacOS, but what about all the other programs, settings, and all your data?

## Full Disk Backup – Cloning and Imaging

A **clone** of a hard drive is a complete copy to another hard drive. All information needed to boot and run the computer and all the programs, settings, and data are written on the backup hard drive. A clone fills up all the backup hard drive; only ONE clone can be written to the backup drive. To **restore** after the computer's internal hard drive has failed or been corrupted, one can either clone from the backup drive to the computer's (possibly new) internal drive or remove the failed drive and install the backup drive in its place. Cloning back should be the first choice on a laptop or all-in-one computer, provided the internal drive hasn't failed. Removing and replacing a laptop's internal drive is a challenging task.

An **Image** of a hard drive is a complete copy written to a single compressed file on another storage device. The compressed image file doesn't typically use as much space as the original data; only the actual space is backed up. Keeping several image files on a single external storage device is usually possible. As with a clone, the image file contains all the information needed to boot and run the PC, along with all the programs and data. However, the image file is not itself bootable.

A bootable recovery disk (CD or DVD) or flash drive is required to restore either a clone or an image file. All the primary backup tools include a tool to create bootable recovery media.

Macrium Reflect Free Edition has been my favorite of the above offerings. It's fast, easy to use, and does everything I need for whole disk backup. And the price was right! # File Backup Tools

Full disk backups are great, but users don't typically run them daily because they take time, and the backup drive has to be retrieved and connected to the computer. This creates a risk that data files that change may not be accurately reflected in the backup. Consider your saved email and contacts, financial and accounting files, and other documents and spreadsheets you may be working on.

# Windows File History or MacOS Time Machine

One approach is to use an automated file backup tool that scans a designated set of folders at some specified time interval (say every hour). It makes a copy of any new or changed files to a backup storage device such as a flash drive, external hard drive, or a shared folder on another computer. I use File History, checking once an hour, to supplement full disk backups for specific key file folders.

For simple one-shot backups, you can still use the built-in file manager programs to select a set of files and copy them to an external flash drive, hard drive, or network-shared folder.

This isn't quite as general as what Android offers, but it takes care of many file types. iTunes also provides an easy way to fully back up all the data on your Apple mobile device into a file on your desktop computer.

Having the iCloud backup enabled on your mobile device is a good idea. This takes care of frequently changing files. Use the iTunes full backup occasionally to ensure ALL your devices' files are backed up.

With these backups in place, if your phone or tablet is damaged, goes up in flames, or gets lost, you can replace the phone or tablet with relative ease, restore all your saved data files, and be back in business.

#### **Backup Tools and Procedures**

It's been a few years since I've written about tools and procedures for backing up your computer. With the growing popularity of smartphones and tablets, the need for backup has expanded to include those devices and traditional Windows, Macintosh, and Linux PCs. I can't stress enough how important it is to make regular backup copies of your data files and of your computer's entire hard drive. The backup landscape has changed somewhat, so it seemed a good time for an update.

# What is Backing Up?

Backing up means accurately copying some or all of the data and software stored on your computer's storage drive. The copy is commonly stored on some type of external storage device that is not generally connected to your computer. The external device may be a USB hard drive or flash drive, a removable rack-mount hard drive, a folder or partition on another computer on your in-house network, or a server elsewhere on the Internet such as Dropbox, MS OneDrive, or Google Drive. A personal backup solution may include some or all of the above.

## Why Back Up?

The reason to make backups is that (putting it politely) *BAD STUFF HAPPENS!* Computer equipment is highly reliable and may run for years without failing, but sooner or later, storage devices fail. More commonly, accidents (drops and spills, turning off the PC's power, power failures and power surges, and so forth) happen, causing a storage device or other device component to fail. A vast array of malicious software waits for any opportunity to attack, damage, or lock up saved data. There's also a fundamental human error – accidentally deleting a file or a folder.

Without a safe backup copy, data saved on your computer may be irretrievably lost. For example, consider digital photos, videos, music, and financial / tax records. Also, if you had to start over with a new, blank hard drive, it would be relatively easy to reinstall Windows, Linux, or MacOS, but what about all the other programs, settings, and all your data?

## Full Disk Backup – Cloning and Imaging

A **clone** of a hard drive is a complete copy to another hard drive. All information needed to boot and run the computer and all the programs, settings, and data are written on the backup hard drive. A clone fills up all the backup hard drive; only ONE clone can be written to the backup drive. To **restore** after the computer's internal hard drive has failed or been corrupted, one can either clone from the backup drive to the computer's (possibly new) internal drive or remove the failed drive and install the backup drive in its place. Cloning back should be the first choice on a laptop or all-in-one computer, provided the internal drive hasn't failed. Removing and replacing a laptop's internal drive is a challenging task.

An **Image** of a hard drive is a complete copy written to a single compressed file on another storage device. The compressed image file doesn't typically use as much space as the original data; only the actual space is backed up. Keeping several image files on a single external storage device is usually possible. As with a clone, the image file contains all the information needed to boot and run the PC, along with all the programs and data. However, the image file is not itself bootable.

A bootable recovery disk (CD or DVD) or flash drive is required to restore either a clone or an image file. All the primary backup tools include a tool to create bootable recovery media.

It was the usual family gathering. And, as usual, Uncle Backup and Aunt Fowlder were arguing. They both use Windows computers, and both save files into folders. Uncle Backup said, "NO, of course not; you cannot have two files with the same name; Windows won't allow it!"

"Oh, don't be silly," said Aunt Fowlder. Of course, you can. I do it myself whenever I copy a file—it copies it with the same name!"

Well, dear reader, who's right? This is a great trick question to bring up over beverages whenever you are in a tech discussion with friends.

The answer? Well, the answer is they are <u>both</u> right! Well, sort of. Fortunately, their argument was overheard by the good doctor, Doc Ewewmint.

"May I help you?" interrupted the good doctor, "Yes, you CAN have two files with the same name if they are in different folders! Let me explain. If you copy a file to a different folder, it can have the same name. But now you must remember carefully which folder you put it in. If you change one of the files but not the other, even if they have the same name, they will now be different."

"Oh, that could cause trouble," said Aunt Fowlder, "so when I copy my files to back them up on a different device, I name the folder "Backup" and the date or something. That way, I know they are not the ones I actively use and change daily. I am thankful that Windows keeps track of the date of each file."

It happens that Aunt Fowlder's husband also overheard the discussion. "Well," he said, "that's all true, of course, but you can have two files that appear to have the same name in the same folder – but they would be of different file types! You could have a word processing document file created in Word, for example, and another with the same name created by Word Pad. They would have different file types -- ".docx" (or ".doc" for Word) or ".rtf" (for WordPad) -- but other than that, they could have the same name." "That's because the file type is part of the name!" said Aunt Fowlder. "My husband is so right about that."

"Yes," said the good doctor, "and the computer keeps all this straight. The computer recognizes the folder path to get to the file you want because you can have the same file name (even with the same file type or extension) in different folders. You could say that the "path" of the folders to get to the file is also part of the file name. Thus, you can never have two files with the same name!"

Well, I'm glad we all settled that and agreed! Now, should I use "Save" or "Save as"?
